GREENVILLE COUNTY REDEVELOPMENT AUTHORITY – 2024 ANNUAL ACTION PLAN:

The Greenville County Redevelopment Authority Board and staff submitted the FY2024 Annual Action Plan for review and acceptance by the Finance Committee. Acceptance and approval allows the GCRA to submit the Annual Action Plan to U. S. Department of Housing for approval.

Imma Nwobodu, Project Manager gave a PowerPoint presentation of the FY2024 Annual Action Plan.

Councilor Seman moved to accept the FY2024 Annual Action Plan as presented. The motion carried unanimously.

COMMUNITY PROJECT APPLICATIONS:

HVAC FOR PIEDMONT YWCA MUSEUM:

This is a Community Project Application in the amount of \$10,000 for the Piedmont YWCA Museum. The funds will be used to assist with replacing the HVAC system.

Nicole Wood, Assistant County Administrator was present to answer questions of the committee.

Councilor Harrison moved to approve the Community Project Application in the amount of \$10,000 for replacing the HVAC system at the Piedmont YWCA Museum. The motion carried unanimously.

RADIO PURCHASE FOR FIRE STATIONS – FIRE CHIEF’S ASSOCIATION:

This is a Community Project Application in the amount of \$20,456 for the Fire Chief’s Association to purchase radios for fire departments within Greenville County.


Nicole Wood, Assistant County Administrator was present to answer questions of the committee.
