The City of Greenville, All that certain strip of land situate in the City of Greenville, County and State aforesaid, said strip being 40 feet in width and 20 feet on either side of a straight line commencing in the centre of Howe and Elkins Streets and running thence N. 21 E. 720 feet to the centre of University Street, the said strip being now in use as a private way known as Howe Street.

Also all that certain strip of land in the City of Greenville, in the County and State aforesaid 40 feet in width, being 20 feet on either side of a line which runs as follows: - Beginning at a point in the centre of University Street, at its junction with Howe Street, and running thence on a 300 foot radius curve to the right 45 degrees; thence S. 0-45 E. 18 feet; thence on a 245 foot radius curve to the left, 16 degrees and 30 minutes; thence on a 285 foot radius curve to the left 38 degrees and 30 minutes; thence S. 15-30 E. 310 feet to a point in the centre of Choice Street and of a private road leading from Montague Hall toward the Judson Alumni Hall.
