KNOW ALL MEN BY THESE PRESENTS, That

a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville, in the State of South Carolina, for and in consideration of the sum of Ten Dollars and the good and valuable consideration DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinabove named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto,

Hardville Investment Company, Inc. all that certain piece, parcel or tract of land, situate in the State and County aforesaid, near the Eastern limits of the City of Greenville and being a part of the property of Overbank Land Company in and adjoining Greenville, S.C. and being bounded and designated abstract No. 4 according to abstract made by A. E. Dalton, Engineer, and recorded in the office of R. M. C. for Greenville County in Plat Book "E" at page 35, said tract having such metes and bounds as are described in said plat and containing acreage of 19.22 acres, (exclusive of railroad right of way).

This deed is subject to the following restrictions, namely, that the property herein conveyed, or any part thereof, is not to be sold or otherwise disposed of to any person or persons of African descent for a period of ten years from the date hereof.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee... hereinabove named, and
its successors

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and its successors, and assigns, against itself and its successors, and against every person whomsoever lawfully claiming, or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, T. F. Hunt, President, and H. L. Todd, Treasurer on this the eleventh day of February, in the year of our Lord one thousand nine hundred and thirteen, and in the one hundred and forty-first year of the Sovereignty and Independence of the United States of America.
