

Judson Mills DEED TO H. F. Davenport

KNOW ALL MEN BY THESE PRESENTS, That Judson Mills

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Two Hundred Twenty five and no/100 DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto.....

H. F. Davenport his heirs and assigns: - All that certain piece parcel and lot of land situate in the State of South Carolina and County of Greenville and being known and designated on the Plat of Judson Mills property as Lot No. 2, "Edgemont," said Lot having a frontage on Piedmont Avenue of 60'-0" and a depth of 155'-0" to the property adjoining of the Judson Mills; said Lot has a frontage abutting Judson Mills property of 60'-0" and a frontage off Easley Bridge Road of 154'-0". For further description of said lot of land see Plat Book "D" page 35, Register of Mesne Conveyance, Greenville, S. C.,

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee...hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, B. E. Gues, President & Treasurer, and B. S. Mills, Secretary, on this the Seventeenth day of September, in the year of our Lord one thousand nine hundred and Seventeen, and in the one hundred and forty first year of the Sovereignty and Independence of the United States of America.
