KNOW ALL MEN BY THESE PRESENTS, That The Judson Mills

a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville, in the State of South Carolina, for and in consideration of the sum of One hundred and twenty five and no/100 DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

Rachel M. Morris, her heirs and assigns
 All that parcel and lot of land situated in the State of South Carolina and County of Greenville, as shown on plat of the Judson Mills property known as "Edgewood" and being designated on said plat as Lot No. 30. Said lot has a frontage on Piedmont Avenue of 60'-0", and a depth of 15'-0" to the property of the Judson Mills. TOGETHER with, all appurtenances, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
 TO HAVE AND TO HOLD all and singular, the premises before mentioned unto the grantee...hereinabove named, and her heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinabove named, and her heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

Mills, Secretary, on this the 30th day of May, in the year of our Lord one thousand nine hundred and eighteen, and in the one hundred and eighty-second year of the Sovereignty and Independence of the United States of America.
