 to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinabove named, (the receipt wherof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto J. L. Land,

all that certain piece, parcel or lot of land, situate

 just outside the City of Greenville, S. C. said lot being
 110.1 as shown by a plat of West Park, recorded in

 R. M. C. Office for Greenville County.


TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
