ab P. Anderson: All those two certain lots of land situate, lying and being in the County and State aforesaid on the North side of the Augusta Road and being known and designated as lots 17 and 18 according to plat of the property of *Realty Corporation* made by *C. S. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee... hereinabove named, and *this* heirs and assigns forever.


