KNOW ALL MEN BY THESE PRESENTS, That Acme Loom Harness and Reed Company a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Ten Dollars and other Valuable Consideration DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto J.P. Ablee

All that certain piece, parcel or lot of land situate on the North side of Hammond St. between Main and Plett Streets in the City and County of Greenville, S.C. and described as follows: Beginning at a point on the north side of Hammond Street 138 ft. from Main St. and running thence N. 36.41 W. 60 ft. along Hammond St. to a stake at corner of lot no. 25; thence with that lot N. 38.55 E. 100 ft. thence S. 36.41 E. 60 feet to line of lot no. 24, thence with that line S. 38.55 W. 100 ft. to the beginning corner.
