

W. A. Williams DEED TO Jos. A. McCullough

STATE OF SOUTH CAROLINA, COUNTY OF Greenville KNOW ALL MEN BY THESE PRESENTS, That I, W. A. Williams of the city of Greenville in the State aforesaid in consideration of the sum of Five Dollars and no other valuable considerations DOLLARS to me in hand paid at and before the sealing of these presents by Jos. A. McCullough (the receipt whereof is here-

by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Jos. A. McCullough, all that certain piece parcel and lot of land situate in the State and county aforesaid in the city of Greenville and on Petigree Street, and known as lot number four of a subdivision of Bayne Laidn property according to a plat recorded in the office of the Register of Moore County for said Greenville county in plat Book C, page 30 and having the following notes and bounds: Beginning on Petigree Street corner of lot number three running thence with Petigree Street N. E. 55 feet, nine inches to corner of lot five on Petigree Street thence with joint line of lots four and five, on Petigree Street, thence with joint line of lots four and five, on Petigree Street, thence parallel with Petigree Street, 55 feet 9 inches corner of lot three, thence with joint line of lots three and four N. 15 W. 196 feet to the beginning corner of Petigree Street and being the same lot of land conveyed to me by W.
