- (c) A single track line of street railway beginning at the end of the double track of the North Main Street Lines of the Greenville Traction Company and extending down College Street to Buncombe Road, thence along Buncombe Road to Church Street, thence down Church to Hammett Street; thence and along a private right of way to the plant of the Monaghan Mills; thence along Hellems Street to Woodside Avenue; thence down Woodside Avenue to Pendleton Road, thence down Pendleton Road to the beginning of the double track at Willis Street; thence with a double track line of street railway down Pendleton Street to Main Street, thence with Main Street to Washington Street, a total distance of thirty four thousand, nine hundred and ninety-five (34,995 feet, and being known as the "Belt Line".

- (f) A single track line of street railway, extending from Sans Souci Junction on the Belt Line of the Greenville Traction Company, and extending to the Sans Souci Country Club, a distance of six thousand, seven hundred and sixty-four (6764) feet.
- (g) A single track line of street railway, beginning at the intersection of North Street and Main Street in said City of Greenville, and extending out North Street a distance of seven thousand six hundred and sixty-seven (7667) feet, and known as the North Street Line.
- (h) A single track line of street railway, beginning at the intersection of McBee Avenue and Main Street and extending along McBee Avenue, to Manly Street, thence down Manly Street to North Main Street, intersecting at this point the North Main Street Line of the Greenville Traction Company, a distance of two thousand, nine hundred and eighty-two (2982) feet.
