Know All men by these presents, That I, G.H. Holmes, of the County of Polk, in the State of North Carolina, in consideration of the sum of Fifty-six and one-quarter Dollars (\$56.25) to me in hand paid at and before the sealing of these presents by Gus Henson, of Glassy Mountain Township, in the State of South Carolina, the receipt of which is hereby acknowledged, have granted, bargained sold and released, and by these presents do bargain, sell, grant and release unto the said Gus-Henson, a certain piece of land situate, lying and being in Glassy Mountain Township, of the County of Greenville, and State of South Carolina, being a part of a tract of land purchased by the said G.H. Holmes from E.M. Guffin, and adjoining lands of R.F. Belue, more particularly described as follows:-

Beginning at a stake in R.F.
