Including Steam Heat, tenant to pay all light and Gas bills. for the term of Three years, to commence the Sixteenth day of August, 1915, for which he is to pay the sum of Six Hundred Sixty Dellars per Annum, to be paid Fifty-five Dellars per month in advance on the Sixteenth day of each month. It is further agreed and understood that the room is not to be used for other than Fruit & Lunch Counter purposes and no gasoline stoves or stove to be used and that no signs shall be tacked or nailed to the outer walls of the building, but if signs are wanted they shall be painted on the windows. Party of second patt is to double line partition wall next to Barber shop to make it close and open at all times from objectionable smoke, fumes and gasses & if necessary to place a section fan to remove objectionable under, smoke or fumes at second parties expense. Is it further agreed that said premises shall not be sublet or this lease assigned without the written corsent, of the Landlord Landlord agrees to continue this lease two years from Aug. 16th 1915 at the annual rental of eight hundred forty Dollars, payable monthly as above in equal instalments provided party of second part given six months notice prior to August 16th, 1918 in writting.
isIt is futher agreed that if said premises shall be destroyed or so indured as to render them

untermatable, all parties hereto from the time of such destruction or injury are released from the

terms of this lease.

It is Futher agreed that if any rent shall be due and unpaid or if the tenant make default in or violate any of the covenants or agreements, terms or conditions in this lease , that thereupon, or within a reasonable time thereafter, the Landlord may terminate this lease and without suit or process reenter and retake possession of said premises and remove all persons therefrom, and the Tenant hereby waives any and all notice from the Landlord of any such intention, or fact of termination, or if no such event occur, will at the ned of the said period covered hereby, quit and surrender said premises in as good condition as reasonable use thereof will permit, except as above provided.

Upon the tenant paying the said rent and at the times stated as above provided, the said Land-

lerd hereby revenants that he may have quiet and peaceable possession of said premises.
