Wallace, of the City of Greenville in the State aforesaid, for and in consideration of the sum of love and affection and the sum of five Dollars to me paid by my son, William A. Wallace, in the State aforesaid, the receipt whereof is hereby acknowledged have granted, bargained sold and released, and by these presents do grant, bargain, sell and release, unto the said William A. Wallace, subject to the reservation of the life estate therein as hereafter specified, all of my right, title and interest of, in and to all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the north side of West Washington Street, between Main and Laurens Streets, fronting on Washington Street twenty-two feet, more or less, and being the same conveyed to me by R. A. Moore by deed dated October 1906, and recorded in Book TTT, page 79.

I reserve in the above lot an undivided one-third interest for my natural life, and if my husband Andrew Wallace should survive me, then in addition an undivided one-third interest I reserve to him for the term of his natural life.

And also except such estate for my natual life as I now enjoy, all my right, title and interest (if any court should hold that I have more that a life estate) in those two lots of land adjoining the above described lot, described in the fourth clause of the will of my father Wm. A. Moore as follows:

I acknowledge that I have heretofore joined in placing two mortgages upon said property and that these debts and all other debts of the Wallace Building are to be paid out of income therefrom before my third of the income (for my life-time) is to be drawn.
