- L. That lessor hereby leases and rents unto lessee for the period of Two years from date, with the privilege of renewal thereafter from year to year upon termsto be agreed upon, that lot of land with the buildings thereon, on the north side of West Washington Street, in, Ward One of Cheefiville City, having a frontage thereon of about ninety (90) feet, being the same lot this day conveyed by the said H.S. Boulware, individually, as executor and trustee and also by his adult children unto J.J. Mc Swain, and the said H.S. Boulware agrees to pay a rental thereon of forty dollars per month, payable at the end of each and every month beginning from the date of this contract, and upon failure of the said H.S. Boulware to pay said rental for any two consecutive months, then his rights under this lease shall at the option of J.J. McSwainbe terminated and ended.
- 2. In consideration of the foregoing the said H.S. Boulware agrees to take good eare of the property and fixtures, and binds himself, to see that no damage is committed thereupon by his family or servants or by any of the sub-tenants, and the lessee agrees to take care of and keep in repair all the water pipes and gas pipes and any electric light fixtures, and that the end of said term to surrender the premises to the lessor in as good condition as he now finds it, necessary wear and deterioration by time exce ted. The kessee agrees that he will replace all window lights or door lights that may be broken during the term of this lease whether broken by himself, his family or sub-tenants.
- 3. Further, it is agreed that said property shall not be leased or sublet not the rights of the lessee assigned without the written consent of the lessor; and that the lesseewill at his own expenses make such changes or alterations in the buildings as he may desire for his own convenience or for that of his sub-tenants, all with the consent of lessor.
