This agreement made and emtered into by and between Pates & Allen Company, hereinaFter designated as party of the first part, and John W. Abercrombte, hereinafter designated as party of the second part:

## WITNESSETH:

That the said party of the first part covenants and agrees to convey to the said party of the second part, his heirs and assigns, the following described real estate, to wit: All that certain piece, parcel or tract of land, situate in Austin Township, County and State aforesaid, and containing eleven (11) acres, more or less, adjoining lands of John W.
