Geer, as Trustee, his heirs, successors and assigns, the right-of-way or easement through our lands situate in the County and State aforesaid near the City of Greenville, bounded by the Easley Bridge Road, lands known as Vardry Heights, lands of Thomas F. Perker and by Judson Mills, for the purpose of constructing and maintaining a trunk sewer line, or lines, extending from Brandon Mills through our lands to Brushy Creek.

It is understood that said sewer line will be run along the bank of the stream passing through our property and that it will be fully covered up and protected, so as not to constitute a nuisance

( Right of Way )

It is understood and agreed as a part of the consideration for this deed, that we, our heirs and assigns, shall be permitted to use the sewer for such houses as may be erected upon the said lands contiguous to said sewer line, including lots heretofore conveyed by any of us from the above described tracts of land, but that this right shall not extend to property which may be hereafter acquired; and to this end we, our heirs and assigns and all persons holding under or through us may connect with said sewer line at any points along where it runs through our lands, that openings will be left in said sewer line.
