(Agreement)

State of South Carolina,

Greenville County.

Agreement executed this 23, day of August 1917, between J.O. Jones and H.B. Bates, partners as Jones & Bates, parties of the first part, hereinafter designated as Jones & Bates, and D.F. Jack (2/5), Charles E. Whitney (1/5), Maxwell Brothers (Briertram, Robert J. and Grover C. Maxwell 1/5), and Henry B. Garrett(1/5), parties of the second part, hereinafter designated as Jack and others, Witnesseth:

That the parties are owners of adjoining lots of land on the west side of South Main Street, in Greenville, South Carolina, between Broad Street and Reedy River. Jones & Bates have erected a two-story brick building upon their lot, and prior to the construction thereof it was agreed that the North wall of their building should be placed one-half upon the property of Jack and others. In addition, it was further agreed that the front stairway of the Jones & Bates building should be located with the joint property line as the center, that is to say one-half of the stairway on the land of Jones & Bates and one-half on the land of Jack and others.

The above building being now constructed in accordance with the agreement, now in consideration of benefit which will accrue to all of the parties interested, the above agreement is hereby ratified and confirmed.

It was understood and agreed as a further consideration for the placing of the said wall and stair-way, and is hereby ratified, that Jack and others shall have the privilege of using the stairway and the party wall if they, their heirs or assigns should at any time in the future decide to build upon their lot, and for such use Jack & Company shall not be required to make any payment.
