Now, therefore, know all men by these presents that We, Alfred Walker, Bettie Sherman, Jane Lewers, Famie Huff, Armie Smith, Nannie Harris, Clara Rosemond, Will Mayes, Sam Mayes, Mary Brown and Eliza Vaughan in consideration of the premises, and five dollars to us in hand paid, at and before the sealing of these presents, by Willis Walker, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Willis Walker, All that certain piece, parcel or tract of land situate, lying and being in Gantt Township, in Greenville County, South Carolina, containing thirteen and 13/100 acres (13.13) more or less, and being part of the land of which the said Alfred Walker died seized and possessed, and having the following metes and bounds: Beginning at a stake on the White-Horse Road, and running thence N. 1 E. 31.58 to a stake; thence N. 86-1/8 W. 2.40 to a stake; thence S. 9-3/4 W. 27.16 to a pin on the white horse road; thence along said road S. 55-4 E. 4.60; thence continuing along said road S. 45 E. 3.50 to stake at the beginning point, and being lot No.2 of the division of the estate of Alfred Walker, as surveyed December 3d, 1917 by W.J. Riddle.

Together with all and singular the rights, members and hereditament and appurtenences to the said premises belonging, or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the said Willis Walker, his heirs and assigns forever.

And we do hereby bind ourselves and our heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Willis Walker, his heirs and assigns, against us and our heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
