Riddle, containing thirteen and 13/100 acres (1313) more or less, and being a part of the land of which the said Alfred Walker died seized and possessed, and having the following metes and bounds: Beginning at an iron pin on White Horse Road, and running the me N. 5.10 W. 37.15 to a stone; thence N. 86-1/8 W. 2.06 to a stake; thence S. 1 W. 31.58 to a stake on White Horse Road; thence along said road 8.00 to the beginning point.

Together with all and singular the rights, members and hereditaments and appurtenances to the said premises belonging, or in any wise incident or appertaining.
