And Whereas all of the above named heirs at law did on the 12th, day of July 1917 execute and deliver to C.P. Rodgers their power whereby they appointed the said C.P. Rodgers their true and lawful attorney for them and in their stead, to make partition of said land by dividing same into nine tracts and allotting to each heir the tract drawn by him, as will appear more fully by said power of attorney;
