(Contract to sell land)

Agreement in duplicate between S.W. Reams and J.L. Grahl, Witnesseth:-1. That the said S.W. Reams binds himself, his heirs and assigns, to convey to said J.L. Grahl, by good fee simple deed, that lot of land situate in said County and State between Woodside and Monaghan Mills, described as follows: Upon compliance with the terms and conditions of this contracts All that piece, parcel or lot of land situate, lying and being in the County and State aforesaid, about one and one-half miles west of Greenville Court House and being a portion of a sub-division known as "City View". Beginning at a stake on the west side of Henderson Street, joint corners of lots #62 and 63 and running thence in a westernly direction with joint lines of said lots one hundred and fifty feet (150) feet to a stake on an alley; thence in a Northernly direction with said Alley fifty feet (50) to a stake corner of lots #62 and 62; thence in an Easternly direction with lines of said lots one hundred and fifty feet to a stake on Henderson Street; thence in a southernly direction with line of said Street fifty (50) feet to the beginning corner and being known as lot #62, according to a plat made by W.A. Adams, Surveyor, said plat being recorded in the office of R.M. C. for Greenville County. Also, see deed book Vol. 43, page 50 in R.M.C. Office for said County. II. The said J.L. Grahl agrees to pay to the said S.W. Reams the sum of Two hundred and fifty 250.00) dollars for the purchase price of said land, to be paid as follows: 10.00 cash, the receipt of which is hereby acknowledged; and the further sum of \$10.00 monthly payable on the 1st day of each month, beginning December 1st, 1918, with interest thereon at the rate of 8% per annum to be computed and paid semi-annually until the full amount is paid, with 10% additional as attorneys fee in the event of any litigation or intervention of any attorney in order to collect the amount due or to enforce said contract. And the said J.L. Grahl agrees to faithful make the payments aforesaid at the proper time or times

(time being of the essence of this contract) and to keep all taxes on said property paid and in case the said J.L. Grahl fails to make said tax payments or payments for the purchase price of said property for two successave months or becomes in arrears for any two months then his rights under this contract shall cease and determine, and all payments made by the said J.L. This contract is binding upon both parties herein, their heirs and assigns, and upon the performance of the conditions shall remain in full force and effect; otherwise to be null and void and subject to the provisions above set forth.
