Whereas, Mrs. Harriet D. Wilkins is the owner of a certain lot of land situate on the north-east corner of South Main Street and River Street, in the Fifth Ward of the City of Greenville, in said County and State, upon which lot there is a brick store building having its front wall approximately at right angles to its side well; and whereas the said River Street is not exactly at right angles with the said South Main Street, and the owners of certain other lots of land fronting on the said South Main Street, east of the lot first above referred to, desire to erect buildings upon their said lots and to place the front walls of said buildings nearer to said South Main Street than the south-east corner of the building first above referred to, and the said Mrs. Harriet D. Wilkins is willing to re-locate the front wall of her said building so as to conform to said proposed new building line to be adopted by all of the buildings to be erected in that vicinity; Now, therefore, in order to permit the adoption of said new building line and the construction of all buildings in that vicinity up to said building line, know all men by these presents that the City of Greenville, a municipal corporation duly organized under and by virtue of the laws of said State, in consideration of the premises and in further consideration of the sum of one Dollar to it in hand paid at and before the sealing and delivery of these presents by J.C. Haley (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell, release and forever quit claim unto the said J.C. Haley and his heirs and assigns forever all of the right, title, interest, estate, easement, claim and demand whatsoever, both at law and in equity, which the said City of Greenville has now or might at any time hereafter have or assert in and to the strip of ground lying between said proposed building line and the front or south boundary line of lots eighteen and nineteen on the plat hereinafter referred to, conveyed to the said J.C. Haley by Greenville Trust Company by deed bearing date 15th, 1918; the strip of land hereby conveyed having the following metes and bounds, according to a revision made on July 20, 1918, by R.E. Dalton of a plat previously made by him from a survey on January 10, 1918; said plat having been recorded on April 15, 1918, in the office of the Register of Mesne Conveyances for said County and State in plat Book "E", at page 90, to; wit: Beginning at a stake on the north side of South Main Street thirty (30) feet from River Street, on the south-east corner of the brick store building belonging to Mrs. Harriet D. Wilkins (this stake being also the south-west corner of lot No. 19 on said plat); and running thence along the south boundary lines of lots Nos. nineteen and eighteen on said plat N. 85° 59' E. fifty (50) feet to a stake on the south-east corner of lot No. 18 on said plat; thence S. 10° 38' E. two and one-tenth (2.1) feet to a stake on said proposed building line (marked "revised street line" on said plat); thence along said "revised street line" S. 85° 01' W. fifty (50) feet to a stake on the south-east corner of the triangular lot this day conveyed by said City of Greenville to Mrs. Harriet D. Wilkins; thence along line of last mentioned lot N. 10° 38' W. two and nine-tenths (2.9) feet to the beginning corner. This deed is executed in pursuance of a resolution duly adopted by the City Council of Greenville

at its regular meeting held on the 25rd, day of July, A.D. 1915.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.
