is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

W. W. Miller: All that certain lot, piece or parcel of land  
 situate, lying and being in the state of South Carolina  
 and County of Greenville, in the Fifth Ward of the City of  
 Greenville, having the following metes and bounds, to-wit:  
 Beginning at a stake on the south side of Perry Avenue on  
 the Northwest corner of a lot now or formerly belonging  
 to Alvin J. Dean and running thence Westward along  
 the south side of said Perry Avenue Ninety-three (93) feet to  
 a stake on said Avenue, on the Northeast corner of a lot  
 now or formerly belonging to Mrs. M. L. McNeill, thence  
 southward along line of her lot two hundred (200) feet to line  
 of lot now or formerly belonging to Mrs. J. S. Cureton; thence  
 eastward along line of the Cureton lot Ninety-three (93)  
 feet to line of the A. J. Dean lot; thence northward along
