R. F. Foster: all that certain piece, parcel or lot of land, situated in the State and County aforesaid, and having the following metes and bounds, to-wit:—Beginning at a point on Cox Street, and runs thence with said street, N 75° E 60 feet to a stake, corner of lot #32; thence along the line of lot #32, S 15-15 E. 140.6 feet to a stake; thence S 75-30 W 60 feet to a stake; thence N. 15-15 W 140 feet to the beginning corner.

Also all that other piece, parcel or lot of land situated in the State and County aforesaid, and having the following metes and bounds, to-wit:—Beginning at a point on Cox Street, and runs thence with said street N. 75° E 60 feet to a stake, corner of lot #31; thence along the line of this lot, S 15-15 E. 141.2 feet to a stake; thence N. 75-30 E. 60 feet to a stake; thence N. 15-15 W. 140.6 feet to the beginning corner.

Also all that other piece, parcel or lot of land situated in the State and County aforesaid, and having the following metes and bounds to-wit: Beginning at a point on Cox Street and runs thence with said street N. 75° E. 60 feet to the corner of lot #30; thence along the line of this lot, S 15-15 E. 141.8 feet to a stake; thence N. 75-30 E. 60 feet; thence N. 15-15 W. 141.2 feet to the beginning corner.

Also all that other piece, parcel, or lot of land situated in the State and County aforesaid, and having the following metes and bounds, to-wit: Beginning at a point on Cox Street and runs thence with said Street N. 75° E. 60 feet to corner of lot #29; thence along the lines of lots #29 and 28, S 15-15 E. 142.4 feet to a stake; thence N. 75-30 E. 60 feet; thence N. 15-15 W 141.8 feet to the beginning corner.
