is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Third Presbyterian Church, a religious and charitable corporation duly organized, wended and in obedience to the laws of said State, and its successors and assigns, all that certain lot, piece or parcel of land situate, lying and being in the State of South Carolina and County of Greenville in the First Ward of the City of Greenville known and designated as lot No. 1 on a plat made by R. E. Dalton, dated August, 1916, and recorded in the office of the Register of Deeds Conveyances for said County and State on the second day of September, 1916, in Plat Book "E" at page 4, and having according to such plat, the following metes and bounds, to wit: Beginning at an iron pipe on the north corner of Buncombe and Echole Streets, and running thence along said Buncombe Street N. 33° 30' W. one hundred and nine (109) feet to a pipe on the corner of lot No. 2; thence along line of last mentioned lot N. 56° 30' E. one hundred and fifty (150) feet to an iron pipe on line of lot No. 3; thence along line of last mentioned lot S. 18° 34' E. twenty-nine (29) feet to an iron pipe on the corner of lot No. 3; thence along last mentioned lot N. 73° 15' E. forty-five and two-tenths (45.2) feet to an iron pipe on line of lot No. 5 on corner of lot formerly belonging to Jacob Sullivan, thence along the Sullivan line S. 16° 33' E. one hundred (100) feet to an iron pipe on the north west side of Echole Street; thence along said street S. 66° 27' W. one hundred and fifty-nine (159) feet to the beginning corner. Almost all of the lot hereby conveyed was conveyed to me, the said W. Austin Hudson, by Mrs. Agnes M. Caldwell and Mrs. Susan M. Bull by deed bearing date December 18, 1906, and recorded in said office on January 23, 1907, in Book "TTT," at page 454. A small portion of the lot conveyed hereby was conveyed to me, the said W. Austin Hudson, by H. P. McGehee et al., Trustees of the estate of W. H. Irvine, bankrupt, by deed bearing date July 14, 1916, and recorded in said office on the day of its date in Book No. 40, at page 247.
