is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Blanche E. Thomason, her Heirs and Assigns, all my undivided right, title and interest of, in and to all those two lots or parcels of land situate, lying and being in the Fifth Ward of the City of Greenville, in the County and State aforesaid, and on the North side of Chest Street, and having the following metes and bounds to wit: The first a larger lot beginning at an iron pin 3 $\frac{1}{2}$ on said Chest Street one hundred feet from corner of Chest and Market Street, and running thence along said Chest Street N. 70 $\frac{1}{2}$ E. ninety-six feet to an iron pin 3 $\frac{1}{2}$, Clegg's corner; thence with Clegg's line, N. 19 $\frac{1}{2}$ W. sixty-four feet to an iron pin 3 $\frac{1}{2}$, Mrs. Linsey's corner, thence with her line S. 71 $\frac{1}{2}$ W. ninety-five feet to an iron pin 3 $\frac{1}{2}$; thence S. 18 $\frac{1}{2}$ E. sixty-five feet to the beginning corner, containing 6160 sq. ft. more or less. The other parcel or lot bounded as in all strip lying next adjoining on the west, and having the following metes and bounds, to wit: Beginning at an iron pin 3 $\frac{1}{2}$ on Chest Street and running thence with said street N. 70 $\frac{1}{2}$ E. four feet to an iron pin 3 $\frac{1}{2}$, former of first described lot; thence with the line of said lot N. 18 $\frac{1}{2}$ W. Sixty-five feet to an iron pin 3 $\frac{1}{2}$ on Mrs. Linsey's line, thence with her line S. 71 $\frac{1}{2}$ W. forty feet to an iron pin 3 $\frac{1}{2}$, Mr. O. McHugh's corner; thence with his line S. 18 $\frac{1}{2}$ E. sixty-five feet to the beginning corner. All of the above described lots of land are the same conveyed to me and B. E. Thomason by William D. Bolt the 21st day of February, 1912, recorded Vol. 17, page 462. Also, my undivided right, title and interest of, in and to that other parcel or lot of land, situate in the City and County of Greenville, South Carolina, fronting Carrer Street (map Park Avenue) one hundred and four feet and beginning at the intersection of said street and a ten foot alley, which runs parallel with Haquayworth's and Beach's lot, thence one hundred and thirty-five feet and eight inches to the middle of the Tan Yard Branch, thence up the Tan Yard Branch about ninety-four feet to the corner of lot sold by J. C. and Blanche Jafford to W. T. Henderson and others, thence along the East side of said lot to a corner on Carrer Street, said corner being one hundred and sixteen feet from the corner of Trusses and Carrer Street; thence along Carrer Street one hundred and four feet to the beginning, being the lot conveyed to me and Blanche Thomason by J. W. Cash, the 10 day of April, 1912, and recorded Vol. 17, page 842.
