KNOW ALL MEN BY THESE PRESENTS, That Wm. J. D. Wood B. G. Bennett,  
and J. P. Few, Trustees of the First Methodist Church  
of the Town of Greer, S. C.  
 in the State aforesaid  
 in consideration of the sum of  
Five Dollars and other considerations DOLLARS,  
 to us in hand paid  
 at and before the sealing of these presents by W. M. Ballenger, C. L. King and W. R.  
Bailey as Trustees of Greer Circuit Parsonage

(the receipt whereof

is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said  
 W. M. Ballenger, C. L. King and W. R. Bailey, Trustees of  
 Greer Circuit Parsonage all our right to land interest in  
 all that piece, parcel or lot of land situate in the  
 County and State aforesaid, Town of Greer. Beginning  
 at an iron spike on north west side of Broad or  
 Mostillar street eight feet from curb stone and run  
 thence North 58 West 200 feet to an iron pin, new  
 mark, D. D. Davenport corner, thence North 59 West  
 90 feet and 4 inches to Jack R. Ballenger's corner,  
 New mark, thence South 9 West 52 feet and ten inches  
 Ballenger's corner on Watkins line N. W., thence South  
 74 East 25 feet to Watkins and Church lot corner N. W.,  
 thence South 17 1/2 West 41 feet and 2 inches, on Watkins  
 line, staked, thence South 57 1/2 East 231 feet and 9 inches,  
 stake on side walk eight feet from curb stone, thence  
 North 34 1/2 East 100 feet to beginning and containing  
 25,000 square feet.

In trust, that such premises shall be held, kept  
 maintained and disposed of, as a place of residence  
 for the use and occupancy of the preachers of the  
 Methodist Episcopal Church, South, who may from  
 time to time be appointed in said place, subject  
 to the usage and discipline of said Church, as from  
 time to time authorized and declared by the General  
 Conference of said Church, and by the Annual Con-  
 ference within whose bounds the said premises  
 are situated.

This conveyance is made in accordance with a  
 resolution adopted by the Quarterly Conference of the  
 Greer Circuit held at Greer, S. C. Jan'y 25, 1915, author-  
 izing the board of trustees of the First Methodist  
 Church of the Town of Greer, S. C. to convey above de-  
 scribed property to the Trustees of the Greer Circuit  
 Parsonage.
