J. M. Markley Jr. DEED TO W. M. Trotter Jr.

NOW, KNOW ALL MEN BY THESE PRESENTS, That I, J. M. Markley Jr. of City of Greenville, County of Dade, and State of Florida, in the State aforesaid, in consideration of the sum of Ten Thousand dollars and other valuable considerations, to me in hand paid at and before the sealing of these presents by W. M. Trotter, Jr.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

W. M. Trotter Jr. all that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville and City of Greenville, on the north side of Earle Street, beginning at a point or stake on Earle Street one hundred and thirty feet and eight inches west from the north west corner of Earle and Bennett Streets, and running thence N. 18. 30 E. one hundred forty-four feet more or less, to a stake on Swiss Ave, thence N. 66. 15 W. sixty five feet eight inches to a stake; thence south 18. 30 W. one hundred fifty feet more or less to a stake on Earle street, thence with Earle street S. 71. 20 E. sixty five feet four inches to the beginning corner, being lot No. 16 Sec. "F" of a plat of the Stone Land Company, made by J. B. E. Birnie, June 4th, 1909, said plat recorded in R. M. C. office for Greenville County, in Plat Book A, pp. 337-345.
