NOW, KNOW ALL MEN BY THESE PRESENTS, That of Thos A Putman of Greenville County, in the State aforesaid, in consideration of the sum of ~~Ten dollars five hundred and eighty~~ DOLLARS, to ~~paid~~ in hand paid at and before the sealing of these presents by

6 C White

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

6 C White, his heirs and assigns, all that certain piece of land or tract of land situate, lying and being in the State of South Carolina and County of Greenville in Austin Township, near Mauldin known as Tract #4 of the J W Jenkins Estate, and bounded the following streets and bounds to wit Beginning at a stone 3 $\frac{1}{2}$ on the Greenville & Laurens Road, at corner of Putman's and Tract No. 3, of lands of said J W Jenkins, deceased, and running thence N. 16 $\frac{3}{4}$ E. 5.56 to an angle on said road; thence N. 6 $\frac{1}{4}$ W. 14.08 to a stone 3 $\frac{1}{2}$ on said road; thence S. 72 $\frac{1}{4}$ W. 40.40 to a stone 3 $\frac{1}{2}$; thence N. 73 E. 43.40 to a stone 3 $\frac{1}{2}$; thence N. 3 W. 64 to a post oak stump, thence N. 57 E. 11.63 to the beginning corner, containing 41 acres more or less, less 39 $\frac{35}{40}$ acres sold and conveyed therefrom to Anthony White, see Deed Book "G. heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming the same, or any part thereof.
