(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Henry A. Batson & H. H. Batson, their heirs and assigns forever;
All that piece, parcel and tract of land situate, lying and
being in Bates Township, in the County and State aforesaid
adjoining lands now, or formerly owned by John Langford,
Mrs. Wilkins, Allen Turbey, and others, and having
the following meters and bounds, to wit: Beginning at
N. O. Stump O.M.; running thence N. 19-1/4 E. 11, 61 to a flint
rock O.M.; thence N. 59 W. 22.17 to stake in branch; thence
with the meanderings of said branch 10.90 to a stake
where this branch empties into another branch; thence
S. 62. E. 5.00 to a stone N.O.M.; thence S. 18 W. 5.40 to a
stone N.O.M.; thence S. 87-1/2 E. 21.50 to the beginning
