NOW, KNOW ALL MEN BY THESE PRESENTS, That I, J. F. Freeman of Greenville County in the State aforesaid, in consideration of the sum of Six Hundred DOLLARS, to me in hand paid at and before the sealing of these presents by Andrew Mosley

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Andrew Mosley all that piece or lot of land situated, lying and being in the said State and County, Chick Springs Township on Marrow-bone Creek, Branch waters of Chowee River, adjoining lands of Alfred Taylor & H. M. Shockley and the said J. F. Freeman and having the following metes and bounds, viz Beginning on a stone, the corner of the said H. M. Shockley's land, and running thence N. 53 3/4 E. 6.66 Chains to the mouth of a ditch on the Marrow-bone Creek, thence down the said creek as a line S. 72 1/4 E. 3.93 Chains to the said Alfred Taylor line, thence S. 28 1/2 W. 6.27 chains to a iron pin in the edge of the road, thence N. 86 W. 1.32 chains to the beginning corner, containing One and two-thirds (1 2/3) acres more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

Andrew Mosley, his heirs and assigns, forever.

AND I do hereby bind myself heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

Andrew Mosley his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.

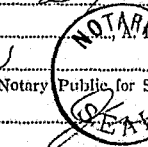
