(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

J. M. Robertson, all my interest of Power in a certain tract of land known as the Estate of the late W. F.
