 in consideration of the sum of Eight hundred dollars (\$800.00) DOLLARS,
 to me in hand paid at and before the sealing of these presents by T. H. M. Dowell of Fountain Inn, S.C.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
T. H. M. Dowell, all that lot or parcel of land lying, being
 and situate near the town of Fountain Inn in County
 and State aforesaid, containing 1.15 acres, more or less,
 and being the same land conveyed to me by D. F. Armstrong
 with the following metes and bounds: bounded by lands
 of D. R. Mahaffey, Babb street and T. H. M. Dowell, commencing
 at an iron pin on north side of Babb street, D. R. Mahaffey
 corner, and running thence N 12.476 to an iron pin;
 thence N 84 1/2 E 2.43 to an iron pin; thence S 1 E 4.76
 to any iron pin on Babb Street; thence S 84 1/2 W 2.43 to
 the beginning corner.
