NOW, KNOW ALL MEN BY THESE PRESENTS, That *S. O. Skelton*

in the State aforesaid,  
in consideration of the sum of *Ten Dollars* and other valuable consideration,  
to me in hand paid at and before the sealing of these presents by *D. W. Cochran*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said *D. W. Cochran*, all that certain piece of land situate, lying and being in the County and State aforesaid, just without the corporate limits of the City of Greenville, on the Augusta Road; and having the following metes and bounds as is shown on plat of property of *D. W. Cochran* by *A. H. Boardman Surveyor*, Dated December 4th, 1918, to wit:-

Beginning at an iron pin joint corner of land of *D. W. Cochran* and *S. O. Skelton*, and running thence a long line of land of *D. W. Cochran* N. 18 $\frac{1}{2}$  E. 1.69 to an iron pin on land of *D. W. Cochran*; thence still with line of *D. W. Cochran* land S. 55 $\frac{1}{2}$  E. 5.75 to an iron pin thence with land of *J. B. Eggleston*, S. 64-30 W. 3.50 to an iron pin joint corner of *D. W. Cochran* and *S. O. Skelton* thence with line of *Skelton's* land N. 37.45 W. 5.35 to the point of beginning, containing 1.23 acres.
