 in consideration of the sum of Twelve Hundred DOLLARS,
 to one in hand paid at and before the sealing of these presents by J. A. Blakely

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said J. A. Blakely. All that piece, parcel or tract of land situate lying and being in Grove Township County and State aforesaid and low branch waters of Reedy Fork Creek about nine and one half miles south of the City of Greenville, containing twenty two and one half (22½) acres more or less, more fully described as follows to-wit: Beginning at poplar 34 or 35 near branch and crossing thence N. 77° W. 11.65 chs. to stone 370m in old road, thence with said road S. 30° W. 9.30 to stone at bridge, thence S. 42° E. 10.74 to iron pin 34; thence N. 65½° E. 21.70 to iron pin 37 NW; thence N. 25½° W. 8.54 to the beginning corner and lying by lands of Mrs. Chas. W. Ashmore, John Davenport and others, and being part of that tract of land conveyed to me by W. C.
