NOW, KNOW ALL MEN BY THESE PRESENTS, That I, R. P. Pitman, of Greenville County in the State aforesaid, in consideration of the sum of Five DOLLARS,

to me in hand paid at and before the sealing of these presents by R. P. Pitman, J. M. Robinson Trustees of Robinsons School District No. 14 S. I have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said R. P. Pitman, J. M. Robinson, Trustees of School District No. 14 S. and their Successors in Office, all that certain piece parcel or tract of land, situate lying and being in the State and County aforesaid on north side of Columbia Road leading from Highland across Latham Mountain and having the following bounds to wit, Beginning on Iron pin in above described road, on line corner of R. P. Pitman + Williams Barton deceased Estate, thence running west along said road to Iron pin in Road, thence in a northerly direction to iron pin, thence in an easterly direction, to iron pin thence in a southerly direction along line of R. P. Pitman + William Barton Deceased Estate to the beginning corner, containing 1/2 acre more or less and bounded by R. P. Pitman on South West + North + on East by William Barton Deceased Estate
