 NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Amy Gertrude League
 in the State aforesaid,
 in consideration of the sum of Two Thousand DOLLARS,
 to me in hand paid at and before the sealing of these presents by Elmira P. Merrick

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Elmira P. Merrick, her heirs and assigns, all that tract or parcel of land, situate in the State and County aforesaid, and having the following metes and bounds, Beginning at a locust post corner of J. W. Ross land on Buncombe Road; thence along said road in a Northernly direction seventy (78) eight feet to a stake; thence in an Easternly direction two hundred and eighty feet (280) to a cedar post, thence in a Southernly direction seventy (78) eight feet to a stake, thence in a Westernly direction two hundred and eighty (280) feet to the beginning corner, and being the same land conveyed to me by W. H. Hamilton by deed dated the 26th day of October 1911, and not yet recorded. This deed was repeated for the purpose of conveying my right, title and interest in the above described tract of land.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Elmira P. Merrick, her heirs and assigns, forever.

AND I do hereby bind myself my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Elmira P. Merrick, her heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
