Book his heirs and assigns, all that piece, parcel and lot of land situate in the State and County aforesaid in Ward 6 of the City of Greenville on the south side of Cleveland Street, Beginning at a pin on the south side of Cleveland Street, joint corner of H. T. Book and J. W. Norwood and running thence S. 3 West 37 3/2 feet to a pin; thence N. 85 W. 185 ft to a pin; thence N. 38. 34 3 feet to a pin on Cleveland Street; thence with the South side of Cleveland Street N 84 1/2 ft to beginning corner and containing one and 52/100 (1.52) acres, more or less, being part of the old Judson home place.
