(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

C.B. Holliday, his heirs and assigns forever, All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville on the North east side of Main Street and Stone Avenue and having the following metes and bounds: Beginning at an iron pin on the northeast corner of Main Street and Stone Avenue and running thence with Stone Avenue S. 73 E. 110 feet to a point on said Avenue; thence N. 17 E. 50 feet to an iron pin; thence N. 73 W. 110 feet to an iron pin on Main Street; thence with said Street S. 19 W. 50 feet to the beginning corner.
