(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said *E. W. Blythe*, all that certain piece, parcel or lot of land situate, lying and being in the City of Greenville State and County aforesaid, and having the following meter and bounds, to-wit: Beginning at a stake on East side of Palmetto Ave. cor. lot #66 and running thence along said ave.
