(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said Laura A. Stinespring, her heirs and assigns, all that piece, parcel and lot of

land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on Mulberry and Pinckney Streets, and running thence with Mulberry Street N. 59-3/4 E. 100 feet to a stake; thence N. 34-1/4 W. 72 feet to a stake; thence S. 54-1/2 W. 100 feet to a stake on Pinckney Street; thence with Pinckney Street S. 36-1/2 E. 62 feet and four inches to the beginning corner, containing 7,050 square feet, more or less, and being same land conveyed to me by J.
