McDow, All that certain lot of land situate in the County and State aforesaid, just north of the City of Greenville, having the following metes and bounds, to-wit:
 Beginning at an iron pipe on the south side of a proposed street 228.7 feet from the west side of North Main Street Extension, corner of Lot No. 3, Block "A", of proposed sub-division of the Hindman property, said iron pipe being N. 23-30 E. 200 feet from the intersection of lot lines 3 and 4, produced to property line of Lucy L. Hindman and H.M.
