Asbury, of the County of Greenville in the State aforesaid, in consideration of the sum of Ten (10.00) Dollars and other valuable considerations to me in hand paid at and before the sealing of these presents by J. H. Rush, (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said J. H. Rush, his heirs and assigns, the following described real estate to wit: All that piece, parcel and lot of land, situate, lying and being in Ward Three of the City of Greenville, County and State aforesaid, adjoining lot of James M. Pherson and fronting on Academy Street, and having the following metes and bounds, to wit: Beginning at a point on Academy Street at corner of Martha C. Hoddard's lot 150 feet and 4 inches from the northeast corner of the intersection of M. Bee Avenue and Academy Street, and running thence with line of said Martha C. Hoddard and Rutledge S. 70.45 E 70 feet and 3/4 inches to a stake on line of parsonage lot of First Baptist Church, thence with said line N. 19 1/2 E. 49 feet and 4 inches to a stake, thence N. 70.45 W. 69 feet and 5 inches to a stake on Academy Street, thence with line of Academy Street, S. 63 1/2 W. 50 feet to the beginning corner, and being the same lot of land which was conveyed to me by Judley P.
