NOW, KNOW ALL MEN BY THESE PRESENTS, That I, W.L. Smith of Greenville County

In consideration of the sum of twenty-nine hundred and fifty (\$2950.00) DOLLARS,
to me in hand paid at and before the sealing of these presents by

W.A. Martin

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said W.A. Martin: All that certain piece, parcel and lot of land situate, lying and being

in the County and State aforesaid in Greenville Township and designated as Lot No. 3 of land known as "Cherokee Park", according to a plat thereof, made by E.H. McCullough, C.E., Oct. 6/96

A.D. 1909 and having the following metes and bounds, to-wit:

Beginning at an iron pin on the corner of the Augusta Road and a new Street, seventy-five feet wide, known as "Catechee Road", and running thence S. 47-1/2 E. 51 feet along the South side of said Augusta Road to an iron pin; thence S. 34 W. 185 feet along line of lot No. 2 to an iron pin; thence N. 63 W. 51 feet along line of lot No. 5 to an iron pin on Alley; thence N. 27 E. 3 feet and 6 inches to an iron pin on said alley; thence along said alley N. 23 W. about thirty-eight (38) feet to an iron pin on said Catechee road; thence along said Catechee Road by a curving line in a Northeasterly direction 171-1/2 feet to the beginning corner; and being the same lot of land conveyed to me by J.D.
