(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said J. H. Watson, his heirs and assigns forever:
 All that lot or parcel of land, situated in Butler Township, County and State aforesaid and having the following meter and bound to wit: - Beginning at a stone 34 m on Brushy Creek, running thence 8 33 W. 11.20 to B. O. 370 to stone 34 m, thence 8 59 E. 46.35 to a stone 34 m, thence 13 1/2 W. 8.70 to stone 340 thence 8 75 E. passing a R. O. 3 24 88 to a stone 340, thence W. 3/4 W. 1.50 to a R.
