NOW, KNOW ALL MEN BY THESE PRESENTS, That L. Lawrence E. White of Greenville County and in the State aforesaid

in consideration of the sum of Seven Hundred 00 DOLLARS, to me in hand paid at and before the sealing of these presents by J. F. Tucker of Greenville

county (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said J. F. Tucker

All that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina about one mile from Cabestee Mills, near the road to Mauldin, being a part of a tract conveyed to J. D. White by V. D. Davidson, adjoining lands of J. D. White, C. C. White and P. Rodd L. Tract, and bounded as follows: Beginning on a rock, thence S. 24 1/2 N. 3.98 to a B. G. shingle S. 21 1/4 N. 100 to a rock, 37 C. m., thence S 22 1/2 E. 7.00 to a rock, 37 C. m., thence S 47 3/4 E. C. 63 to a stake, L, thence N. 16 3/4 E. 26.44 to the beginning together with a right of way along the line between the land of J. D. White and C. C. White, out to the road leading out to the public road containing the above more or less.

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said J. F. Tucker, and his heirs and assigns, forever.

heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
