Know all men by these presents, that H. C. McCarter of said County and State, in consideration of the premises, and of the sum of Twelve & 75/100 Dollars to me in hand paid by the City of Greenville, South Carolina, the receipt whereof is hereby acknowledged do hereby grant unto the said City of Greenville, its successors and assigns, the right, privilege, and easement to go in and upon that tract of land situated in said County and State, bounded by lands of Rosman Estate on the North; J. H. Roberts on the East; Furman Roberts on the South and J. H. Baitsor & J. B. Bell on the West, and to construct and maintain in, upon and through said premises, in a proper manner, with poles, towers, wires and other necessary apparatus and appliances, lines for the purpose of transmitting power by electricity and telephone service, together with the right at all times, to enter upon said premises for the purpose of inspecting said lines and making necessary repairs and alterations thereon; together with the right to cut away and keep clear of said lines, all trees and other like obstructions that may in any way, endanger the proper operation of the same. The payment above specified is accepted in full settlement of all claims for said easement. Any damage to crops planted, shall be paid for at a price to be agreed upon, and if such can not be arrived at mutually, the damage shall be determined by arbitrators one to be chosen by me, one by the holder of this grant, and the two so appointed, to select a third. The decision of any two of the three arbitrators shall be final. The above amount is based on four poles, & if more than that number are placed on the above premises I am to receive three dollars for each additional pole, any wood cut is to be neatly corded up on the right of way for me. Bond for title.

This indenture made by and between Allen J. Sullivan, party of the first part and N.P. Chapman, party of the second part, witnesseth:-

That the party of the first part for and in consideration of the sum of Forty-seven dollars and sixty-two cents (\$47.62) per acre, does hereby agree to convey to the said party of the second part, all of that piece, parcel or tract of land containing 105 acres, more or less, as is shown by a re-survey of the Edward Holliday land in Dunklin Township, County and State aforesaid on the waters of Mt. Creek.

That the said party of the second part does hereby agree to pay the purchase price in the following manner, to-wit: Six hundred fifty (\$650.00) upon the signing of this agreement, the receipt whereof is hereby acknowledged. The remainder to be carried by the party of the first part for a period of eight years at 8% per annum, one-eighth of said remainder to be paid each year provided nevertheless that if to the minds of the parties hereto, the party of the second part is unable to make a payment of one-eighth of the amount in any year, that said deferred payment may be carried at the option of the party of the first part!!!

~~It is further agreed that when the party of the second part shall have paid to the party of the first part, one-third of the entire purchase price,~~
~~this 2nd day of Dec 1918,~~
the party of the first part will then make a deed conveying the land in fee to the party of the second part and take his note for the remainder said note to be secured by a first mortgage on the premises herein to be conveyed.

The parties hereto do hereby bind themselves, their heirs, executors and administrators.
