Whereas, Norris Brothers is now the owner of the lease to Long Blue Grenite Company under which S.A. Nettles holds and it is the desire and intention of the parties to this instrument that by reason of the execution of the same S.A. Nettles shall not lose the rights and security of a landlord for the rent agreed to be paid him hereunder.

Now, therefore, in consideration of the premises and the agreements herein contained, S.A. Nettles does hereby lease and sublet unto Norris Brothers that certain rectangular lot of land on the South side of East McBee Avenue, in the City of Greenville, County and State aforesaid immediately East of the Baptist Courier Company's Building and having a frontage of thirty-six (36) feet and extending back from the street one hundred and forty (140) feet to the railroad track, being the same on which a brick store house has been erected by lessor, for the term commencing June Ist, 1919, and ending August 31st, 1930, at a rental of twenty-four dollars (\$24.00) per month, payable in advance on the first day of each and every month until the expiration of said term. This agreement made and entered into by and between Mary R. Blakeley, hereinafter referred to as the Seller, and J.A. Martin, hereinafter referred to as Purchaser,

W-T-T-N-E-S-S-E-T-H:

That the Seller hereby agrees to sell and convey to the Purchaser, for the consideration hereinafter mentioned, all that certain tract of land situate on the Laurens Road, in the County of Greenville, State of South Carolina, about seven miles from Greenville Court House, containing 113-1 acres, more or less, and being the same tract of land conveyed to the Seller by S.J. Douthit, Master by deed dated November 2nd, 1885, deed recorded in R.M.C. office for Greenville County in Book TT, page / 502, said tract of land adjoining lands of Mrs. E.S. Smith, Rev. E.P. Taylor, Mrs. John E.Forrester and others, and the Purchaser hereby agrees to pay the Seller for said tract of land the sum of Twenty Thousand and five hundred dollars (\$20,500.00), due and payable as follows:

Two thousand dollars (\$2,000.00) in cash, the receipt whereof is hereby acknowledged, and the remainder as follows: Three thousand dollars (\$3,000.00) on January 1st, 1920, and the balance five years from January 1st, 1920, with the privilege of paying the whole or any part thereof at any interest paying period, the credit portion to bear interest at the rate of six per cent per cent per annum, payable annually until paid.
