Henry Madden of Greenville., two or more of the officers or agents appointed to supervise or manage the affairs of Dunean Baptist Church, a church which has been duly and regularly organized, did on the 4th, day of September A.D. 1919, file with the Secretary of State a written declaration setting forth:

That at a meeting of the aforesaid organization held pursuant to the by-laws or regulations of the said organization, they were authorized and directed to apply for incorporation. That the said organization holds, or desires to hold, property in common for a Religious, Educational, Social, Fraternal, Charitable or other eleemosynary purposes, or any two or more of said purposes, and is not organized for the purpose of profit or gain to the members, otherwise than is above stated, or for the insurance of life, health, accident or property; and that three days' notice in the Greenville Daily News, a newspaper published in the County of Greenville, has been given that the aforesaid Decleration would be filed. And Whereas, That said Declarants and Petitioners further declared and affirmed:

First. Their names and residences are as above given.

Second. The name of the proposed Corporation is Dunean Baptist Church.

Third. The place at which it proposes to have its headquarters or to be located is Dunean Mills, Greenville, S.C.

Fourth. The purpose of the said proposed Corporation is. To own a place of worship and conduct religious services or other services incident to the

conducting of a Baptist Church, to hold property in common for a Religious, Educational, Social charitable or other eleemosynary purpose or any two or more of them; to borrow money and mortgage its property to secure the payment of the same, and to do any and all things necessary to the carrying on and properly conducting the affairs of a baptist church.

Fifth. The names and residences of all Managers, Trustees or other officers are all as follows: C.J. Ashmore, Greenville, S.C., Trustee.

Sixth. That they desire to be incorporated in perpetuity.

Banks Dove, Secretary of State, by virtue of the Authority in me vested, by Chapter XLVII, Article II, Code of 1912, and Acts amendatory thereto, do hereby declare the said Organization to be a body politic and corporate, with all the rights, powers, privileges and immunities, and subject to all the limitations and liabilities, conferred by said Chapter XLVII, Article II, Code of 1912 and Acts amendatory thereto.
