All my undivided one-half interest in all that piece, parcel or lot of land situate, lying and being in South Carolina and in Greenville County, just beyond W. deede Miles, being known as Lot No. 16 on a plat of Summit View in Block "A", located on the Public Road and Goldfield Street, said plat is recorded in the R. M. C. Office for said Greenville County and State aforesaid in Plat Book "A" page 75. Said lot has a frontage on the public road of fifty feet (50), for the other dimensions and metes and bounds see the above mentioned plat. This being the same lot conveyed to Ella J. Sheppard by A. Schonewetter by deed bearing date February 10th, 1913, said deed being recorded in R. M. C.
